#### **Statistics on privacy injunctions - January to June 2012**

Five injunctions were sought by a male, 2 by a female and the other 2 by a company or organisation Eight of the 9 applications to continue or amend injunctions were applied for “on-notice” This compares to all 3 injunctions continued or varied between August and December 2011

#### **Privacy injunction statistics - August - December 2011**

All 3 injunctions were sought by individuals; 2 were males and 1 was female All 3 of these injunctions were applied for “on-notice” All the injunctions were granted by the court (either under their existing terms or with some variation) Of the 3 injunctions continued or varied during the period August to December 2011:
