As general guidance, where we are instructed to apply for a grant of probate in a very straightforward case the typical fees might be in the range of between £3,25000 - £3,85000 plus VAT A straightforward estate would consist typically of two or three bank accounts and one property all based in the UK with only one or two beneficiaries
